**AGREEMENT STATEMENT**

In order to complete enrollment of my (our) child(ren) listed below, I (We) indicate full agreement with the following statements:

1. I accept the Basis Article of the Lamont Christian School Association as found below.

*Article I. Section 2. Basis: The basis of this society is the infallible Word of God as interpreted in the standards of the faith of the Reformed Church. This society is governed by the following guiding principles: (1) That all things have been created to the end that the Triune God may be glorified in and through them; (2) That God by His wise covenant arrangement has appointed the parent to be responsible for the training of the child to the end that God and His glory shall be central and supreme in life's total experience; and (3) That the training of the child shall be continued under the parent's responsible supervision in a school that carries out the basic God-honoring, God-centered program begun in the home.*

2. The payment in full of any prior commitment (\$ \_\_\_\_\_) is required by June 30, 2020 if your last child is graduating. Current families may have until July 31, 2020 for any previous year's tuition. Any unpaid balance from the previous year must be less than 25% of the current year's tuition. If unable to obtain funds for payment of the total prior balance, I will meet with the Finance Committee before July 1, 2020. Until these criteria are met, enrollment of the new school year is considered conditional.

3. If there is no prior balance by August 31, 2020, I understand that I may make a payment in full by September 1, 2020 with a 2 1/2% discount.

5. I understand that to keep tuition reasonable I will be required to contribute volunteer time to meet the school's needs.

6. In order to ensure your child's enrollment for the fall, this enrollment form is due back to the school by **May 15, 2020**.
